

Value of credit

- Credit received will be based on the number of qualifying acres in each product category
- Qualifying acres for each separate category are the number of matching litres of eligible product purchased and tonnage (MT) of canola contracted with Cargill between September 1, 2025 and April 30, 2026. Canola under these contracts must be delivered before August 31, 2026.
 - Procote Fertilizer requirements: 1 litre to 1 MT
 - Anvol Nitrogen Stabilizer requirements: 1 litre to 1 MT
 - Foliar Fertilizers requirements: 1 litre to 1 MT

Timing of credit

Starting September 1, 2025, you will receive account credit one week after the merchandising contract is established with Cargill up to a maximum of the number of liters of eligible products purchased, using the 1:1 ratio.
